

JAZ: The Homecoming Offer Terms and Conditions – For Baiduri Cardholders only

1. Terms

- 1.1 JAZ: The Homecoming (the “Offer”) is jointly organised by Baiduri Bank Sendirian Berhad (the “Bank”) and The Fork Studios (the “Merchant”) and is subject to these terms and conditions (the “Terms”).
- 1.2 Participation in this Offer constitutes acceptance of these Terms.
- 1.3 Participation in this Offer also constitutes acceptance of the Merchant's applicable terms and conditions, which are available at progresifevents.com/events/jaz-hayat (the “Ticketing Platform”), or upon request.

2. Offer Period

- 2.1 This Offer is valid from **21 August 2026 to 3 October 2026** (both dates inclusive), or until all available seats have been sold, whichever is earlier, unless otherwise determined by the Bank and/or the Merchant at their discretion (the “Offer Period”).

3. Eligibility

- 3.1 This Offer is valid only for purchases made through the Ticketing Platform and for merchandise purchases made at JIS Arts Centre (the “Event Venue”).
- 3.2 This Offer is open to customers who hold any of the following cards (the “Eligible Cards”). Such customers are referred to as “Eligible Cardholders” (each an “Eligible Cardholder”, collectively “Eligible Cardholders”).

- 3.3 Where payment is made using an Eligible Card, the card must be valid, active, and in good standing, as determined by the Bank. Cards that are cancelled, suspended, or terminated shall be disqualified.
- 3.4 To qualify for the Offer, full payment must be made in a single transaction using an Eligible Card through the Ticketing Platform or at the Event Venue via a Baiduri point-of-sale ("POS") terminal, Baiduri Tap2Pay or Baiduri QPay.
- 3.5 Employees of the Bank, Baiduri Finance Berhad, Baiduri Capital Sendirian Berhad, and the Merchant are eligible for the Cash Rebate Offer only, and shall not be eligible for the Lucky Draw, unless otherwise stated.

4. Offer

4.1 Cash Rebate Offer

- 4.1.1 Eligible Cardholders are entitled to the following cash rebate on ticket purchases made through the Ticketing Platform and merchandise purchases at the Event Venue during the Offer Period, with no minimum spend required.

- 4.1.2 Each ticket purchase made through the Ticketing Platform and each merchandise purchase made at the Event Venue is eligible for one (1) cash rebate calculated based on the total amount of that transaction.
- 4.1.3 A cash rebate will be calculated based on the total amount of transaction. There is no limit to the number of transactions eligible for a cash rebate during the Offer Period.
- 4.1.4 Any cash rebate earned will be credited to the Eligible Cardholder's account within three (3) weeks from the transaction date.
- 4.1.5 This Offer is not valid with other ongoing promotions, discounts, offers, vouchers, rebates, or privileges.

4.2 Lucky Draw for 'Photo Session'

- 4.2.1 The 'Photo Session' Lucky Draw (the "Lucky Draw") is open to customers who hold any of the following cards ("Lucky Draw Eligible Cards") and purchase at least one (1) ticket on the Ticketing Platform. Such customers are referred to as "Lucky Draw Eligible Cardholders".

Cardholders who purchase VIP tickets are not eligible to participate in the Lucky Draw, as VIP tickets already include a complimentary 'Photo Session' entitlement.

- 4.2.2 Entries are valid only for ticket purchases made through the Ticketing Platform until **10 September 2026** (the "Validity Period").
- 4.2.3 Fifteen (15) winners will be selected via a random draw conducted by the Bank. Each winner will receive the opportunity to attend a 'Photo Session' on a date determined by the Merchant and may invite one (1) guest.
- 4.2.4 The Lucky Draw will be conducted within two (2) weeks after the Validity Period.
- 4.2.5 Each ticket purchased through the Ticketing Platform during the Validity Period using a Lucky Draw Eligible Card will entitle the Lucky Draw Eligible Cardholder to one (1) entry into the Lucky Draw.

- 4.2.6 Each Lucky Draw Eligible Cardholder may only win one (1) entry to the 'Photo Session'. If the same Lucky Draw Eligible Cardholder is selected more than once, the Bank will redraw and select an alternative winner.
- 4.2.7 Winners will be notified via phone call by the Bank no later than 30 September 2026. The Bank reserves the right to select an alternative winner if a winner is unreachable, declines the prize, or fails to respond within the timeframe specified by the Bank.
- 4.2.8 If a winner is unable or unwilling to attend the 'Photo Session', the prize shall be forfeited and no cash, alternative prize, or compensation will be provided.

5. General

- 5.1 This Offer is governed by the Bank's standard terms and conditions governing the related products and any other documents forming part of the banking agreement.
- 5.2 The Bank and the Merchant reserve the right to amend, vary, suspend, or terminate the Offer or these Terms without prior notice or liability. Where reasonably practicable, notice will be given via the Bank's website.
- 5.3 The Bank's and the Merchant's determination of all matters relating to this Offer shall be final and conclusive.
- 5.4 By participating in this Offer, Eligible Cardholders consent to the collection, use, and disclosure of their personal data for purposes related to the administration of the Offer, including but not limited to eligibility verification, prize fulfilment, record-keeping, and the announcement and publication of winners' names, in accordance with the Group Privacy Notice. Eligible Cardholders confirm that they have read and agree to be bound by the terms of the Bank's Group Privacy Notice, as may be amended, supplemented and/or substituted by the Bank from time to time. - 5.5 In the event of any inconsistency between these Terms and any promotional materials, these Terms shall prevail.
- 5.6 The Terms shall be governed by and construed in accordance with the laws of Brunei Darussalam.
