

REQUIRED DOCUMENTS (All accounts must be opened at a Baiduri Bank branch in person)

1. Sole Proprietor or Partnership

- Certificate of Registration – Section 16 & 17
- Sole proprietor or partners' valid identification documents as per Section 17 and the Bank's proof of identity requirements for individuals¹
- Authorised signatories' valid identification documents (identity card or passport)

2. Limited Companies

- Mandate for Account – Limited Company
- Certification of Incorporation of Private Company
- Form X (if applicable)
- Printed copy of Company Extract
- Memorandum & Articles of Association
- Return on Allotment of Shares
- Valid Identification documents for all shareholders²
- Board Resolution signed by all directors
- All directors' valid identification documents as per Form X and the Bank's proof of identity requirements for individuals
- Authorised signatories' valid identification documents (identity card or passport)

3. Society, Club or Association

- Approval letter from Registrar of Societies or an appropriate authority approving the formation
- Committee Minutes of Meeting signed by the Chairperson
- Chairperson and authorised signatories' valid identification documents (identity card or passport)
- Constitution of the organisation
- List of current office bearers and members of the governing body or committee

¹ Please see Personal Current Account for identification requirements.

² If the significant shareholder is a limited company or partnership, valid identification documents of the limited company's shareholders (signed by shareholders and originals sighted by Bank staff) are required. A copy of the Annual Return on Allotment of Shares of the significant shareholder i.e., the limited company is also required for verification of shareholding.
