Why invest?

1 Payout at Maturity

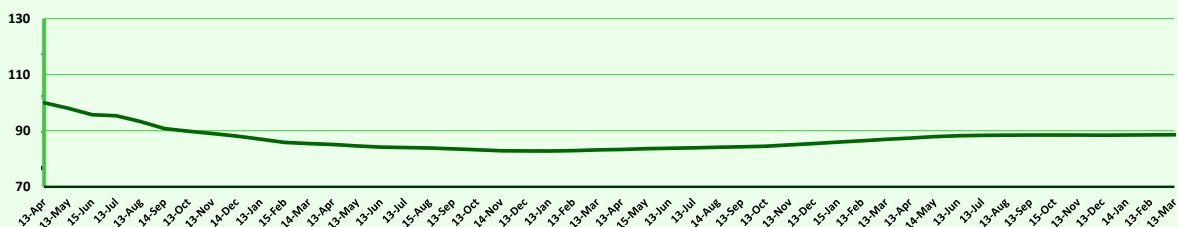

DBS (-3.74%)

Recommendation on DBS Group was downgraded from overweight to neutral by JPMorgan with a target price of of S\$29.

SingTel (-0.95%)

Singtel's Indonesia associate, Telkomsel has created a new fund with an initial budget of US\$40 million to invest in start-ups around the region and undertake other initiatives.

CapitaLand (-9.21%)

CapitaLand is forking out S\$6 billion (\$4.4 billion) to scoop up logistics and industrial assets from state investor Temasek, in a deal the developer said would create Asia's largest real estate investment manager.

Keppel (-2.12%)

Singapore conglomerate Keppel Corp is planning to 1,800 staff this year at its offshore and marine business, the first time the company is hiring for the division after cutting thousands of jobs since 2015.

Singapore Airlines (-3.74%)

Singapore Airlines Ltd on reported its highest ever annual revenue on a jump in passengers, though higher fuel costs nearly halved its profit.
