Payout at Maturity

b. Coupon

i. Guaranteed Coupon

Guaranteed coupon of 10% payable only upon maturity.

ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

The performance of the 5 Singapore Blue Chip companies is equal to the average of the monthly observations of each company throughout the 5 year investment horizon (Compared to the initial level recorded on April 13th 2015) and observe half of it.

The additional coupon is equal to the recorded performance of the 5 Singapore Blue Chip companies minus 10%. Additional Coupon: $[(\text{Average of monthly observations of the 5 Singapore Blue Chips companies} \times 2) - 10\%]$

DBS (-0.10%)

DBS seeks to expand its wealth business in Indonesia. It has acquired some Australia and New Zealand Banking Group Ltd. businesses in Asia to boost its Indonesian retail and wealth customer base.

SingTel (-5.04%)

SingTel dropped after TPG Telecom announced that it won an Australian spectrum auction and plans to build a mobile network in Australia. Singtel derived 52.9% of its third quarter revenue from Australia.

CapitaLand (-0.27%)

CapitaLand announced its plans to expand its multi-sector real estate presence in Vietnam. It was also in negotiations with BlackRock to acquire Asia Square Tower 2 in Singapore.

Keppel (+2.37%)

Keppel Corp cut to Neutral at UBS with Target Price of S\$7.28. Keppel entered into a term sheet agreement with Damen Shipyards Group to sell its Dutch shipyard Keppel Verolme.

Singapore Airlines (+1.80%)

Singapore Airlines and its regional arm SilkAir have signed codeshare agreement with Air-France-KLM. SIA's March Passenger Load Factor recorded 80.1% vs 77.8% YoY.

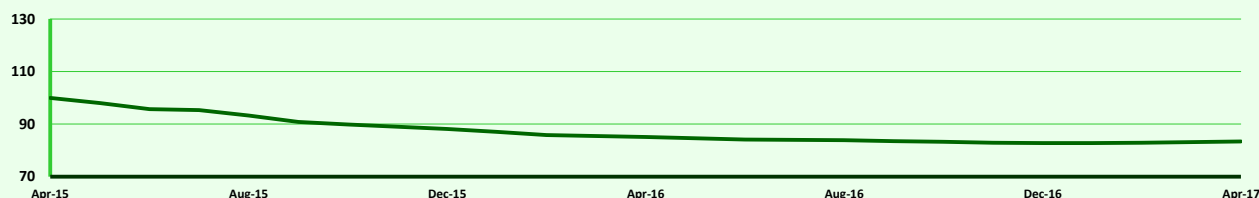
