Payout at Maturity

b. Coupon

i. Guaranteed Coupon

Guaranteed coupon of 10% payable only upon maturity.

ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

The performance of the 5 Singapore Blue Chip companies is equal to the average of the monthly observations of each company throughout the 5 year investment horizon (Compared to the initial level recorded on April 13th 2015) and observe half of it.

Commentary

DBS (+3.28%)

DBS Group raised to Hold vs Reduce at HSBC. DBS to sell Singapore Building to Manulife for S\$358m cash. Singapore banks including DBS are vulnerable to continued oil price weakness, as the country is the largest manufacturer of jack-up rigs.

SingTel (+3.39%)

SingTel's resilient Q3 profit rises 2% to S\$ 972.8m, underpinned by strong core business and higher associates' contribution. SingTel TV Jia Le has selected as the number one prime time pay TV channel with 21% margin over its nearest competitor.

CapitaLand (+10.41%)

CapitaLand cut to Outperform vs Buy at Daiwa Securities. CapitaLand posts 74% rise in 4Q earnings to S\$430.5 mil on higher handover of China project.

Keppel (+5.72%)

Keppel Corp 4Q Net profit plunges 65% to S\$143m vs S\$404.8m from a year ago, due largely to lower contribution from and additional provisions for impairment tied to the offshore and marine division.

Singapore Airlines (+0.30%)

Singapore Airlines cut to Reduce vs Hold at BNP Paribas. Singapore Airlines reported a near 36% YoY drop in net profit to S\$177.2m for its fiscal third quarter ended December 31st 2016.

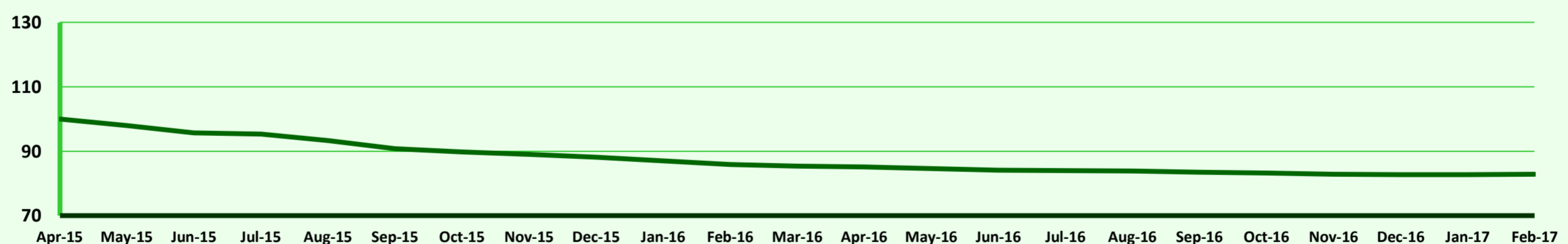
