Why invest?

1 Payout at Maturity

On the maturity date, investor will receive the amount as follows:

100% **10% COUPON**
100% principal amount + 10% Guaranteed Coupon + Additional Coupon

a. Capital Guaranteed

Principal is 100% capital guaranteed only upon maturity

b. Coupon

i. Guaranteed Coupon

Guaranteed coupon of 10% payable only upon maturity.

ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

The performance of the 5 Singapore Blue Chip companies is equal to the average of the monthly observations of each company throughout the 5 year investment horizon (Compared to the initial level recorded on April 13th 2015) and observe half of it.

The additional coupon is equal to the recorded performance of the 5 Singapore Blue Chip companies minus 10%. Additional Coupon: $[(\text{Average of monthly observations of the 5 Singapore Blue Chips companies} \div 2) - 10\%]$

3 Commentary

DBS (+4.55%)

DBS partnered with 7-Eleven Singapore to include its mobile banking and payment apps. According to a press release, the apps joined the lineup of payment schemes like payWave, Apple Pay, and Android Pay in 7-Eleven's 350 stores on 1 January 2018. DBS' apps allow users to scan and make payment with QR codes.

SingTel (-5.01%)

Singapore Telecommunications is going on the hunt for opportunities to cooperate with and possibly invest in digital businesses. The company mentioned that the partnership could be started from commercial collaborations to taking minority stakes (large enough equity stakes) to make cooperation work.

CapitaLand (+7.41%)

CapitaLand is set to divest its share of interest in a group of companies that hold 20 retail malls in China for an agreed value of 8.37 billion yuan (\$\$1.71 billion) to unrelated parties. Each of the 20 malls has an average gross floor area (GFA), excluding car park, of about 40,000 sq m

Keppel (+4.91%)

A Keppel Corp unit and a partner have won a HK\$31 billion (\$\$5.36 billion) contract to design, build and operate a waste management facility in Hong Kong.

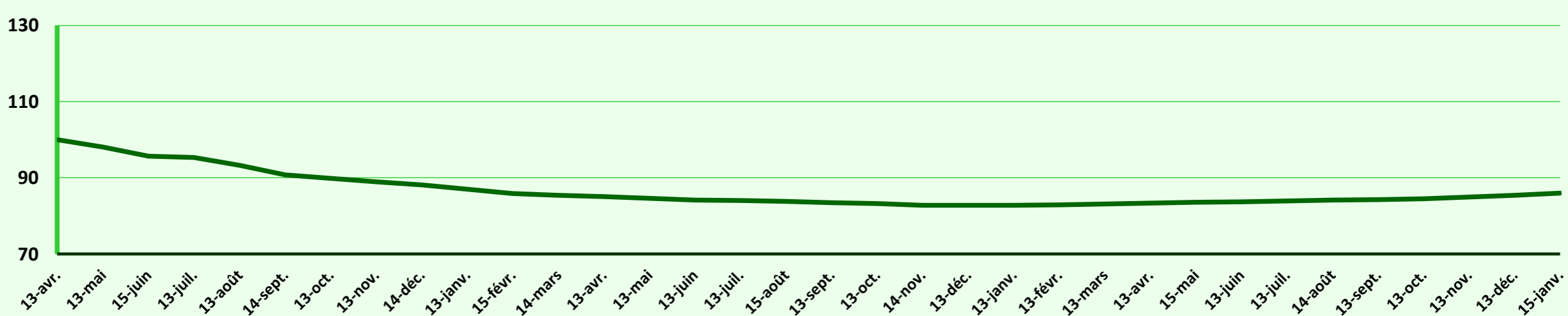
Singapore Airlines (+4.93%)

Singapore Airlines announced the second and third routes for its refreshed Airbus A380 aircraft, which feature the airline's new Suites first class product and other updated cabins. Beginning in February, the A380s will fly from the carrier's hub in Singapore to London and Hong Kong.
