Why invest?

Payout at Maturity

On the maturity date, investor will receive the amount as follows:

100% **10% COUPON**
100% principal amount + 10% Guaranteed Coupon + Additional Coupon

a. Capital Guaranteed

Principal is 100% capital guaranteed only upon maturity

b. Coupon

i. Guaranteed Coupon

Guaranteed coupon of 10% payable only upon maturity.

ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

The performance of the 5 Singapore Blue Chip companies is equal to the average of the monthly observations of each company throughout the 5 year investment horizon (Compared to the initial level recorded on April 13th 2015) and observe half of it.

The additional coupon is equal to the recorded performance of the 5 Singapore Blue Chip companies minus 10%. Additional Coupon: [(Average of monthly observations of the 5 Singapore Blue Chips companies ÷ 2) - 10%]

Commentary

Period from 15 October 2018 to 13 November 2018

DBS (-4.74%)

DBS reported 76% rise in its third-quarter net profit to S\$1.41 billion compared to the same period last year. The earnings were slightly below the market forecasts of S\$1.44 billion.

SingTel (-2,57%)

Singtel reported that the second-quarter net profit was down by 77% to S\$667 million which was the worst quarterly result shown since 2003.

CapitaLand (0.33%)

CapitaLand has won bid for a prime-mixed use Guangzhou site for S\$175 million as it continues its footprint expansion in Guangzhou.

Keppel (-6.55%)

Keppel reported a 15% drop in its third-quarter earnings to S\$225.7 million, mainly caused by a lower contributions from its investment and property divisions.

Singapore Airlines (2.39%)

Singapore Airlines announced a 81% drop in its second-quarter net profit to S\$56 million from a restated profit of S\$293 million last year, due to high fuel prices.

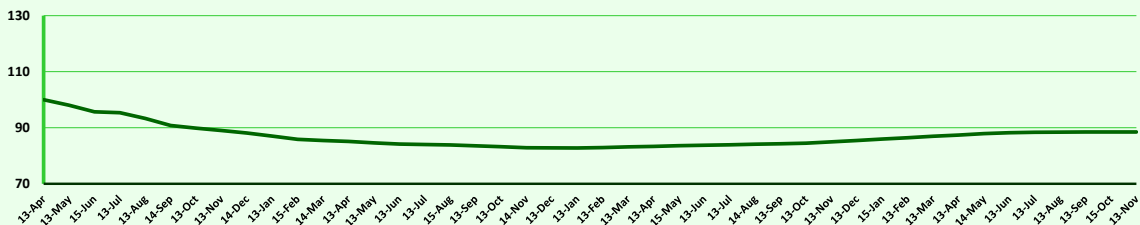
