ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

CapitaLand (-6.12%)

CapitaLand is said to be eyeing the Star Harbour International Centre, a mixed-use development in Shanghai which has been launched for sale with a reserve price of 12.79 billion yuan (S\$2.5 billion).

Keppel (+2.60%)

Keppel would build for Stolt-Nielsen Gas two additional small-scale liquefied natural gas (LNG) carriers worth a total of around S\$105 million.

Singapore Airlines (-3.46%)

Singapore Airlines has priced an issue of S\$600 million notes to fund aircraft purchases and aircraft related payments, it said on Wednesday after market close.

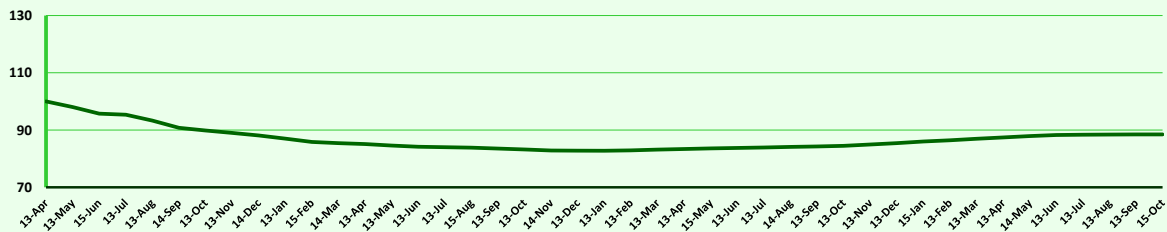
