Why invest?

1 Payout at Maturity

On the maturity date, investor will receive the amount as follows:

100% **10% COUPON**
100% principal amount + 10% Guaranteed Coupon + Additional Coupon

a. Capital Guaranteed

Principal is 100% capital guaranteed only upon maturity

b. Coupon

i. Guaranteed Coupon

Guaranteed coupon of 10% payable only upon maturity.

ii. Additional Coupon

Investor has the possibility to receive an Additional Coupon which depends on the performance of 5 Singapore Blue Chip companies (DBS, SingTel, CapitaLand, Keppel and Singapore Airlines).

The performance of the 5 Singapore Blue Chip companies is equal to the average of the monthly observations of each company throughout the 5 year investment horizon (Compared to the initial level recorded on April 13th 2015) and observe half of it.

DBS (+2.28%)

DBS Private Bank and brokerage DBS Vickers Securities (Thailand) are partnering to double wealth assets managed in Thailand to S\$8 billion from S\$4 billion by 2023.

SingTel (+1.58%)

Singtel will invest \$45 million over the next three years in organising training programmes for its workers to deepen their skills and knowledge in order to fuel the digital economy.

CapitaLand (+5.83%)

The eight Singapore-listed stocks under the enlarged CapitaLand group generated higher average returns than their regional and global peers in the year to date (YTD), while also significantly outpacing broader benchmarks.

Keppel (+4.71%)

KEPPEL Land China is buying another completed commercial property in Beijing's Haidian district through its acquisition of Beijing Shunxiangren Enterprise Management for around ¥178.6 million (\$34.6 million).

Singapore Airlines (+3.12%)

SINGAPORE Airlines (SIA) will take over its regional wing SilkAir's services to the South Korean port city of Busan, starting from Oct 28. SIA will use a bigger aircraft on the route, boosting seat capacity by 76%, in order to meet growing travel demand.

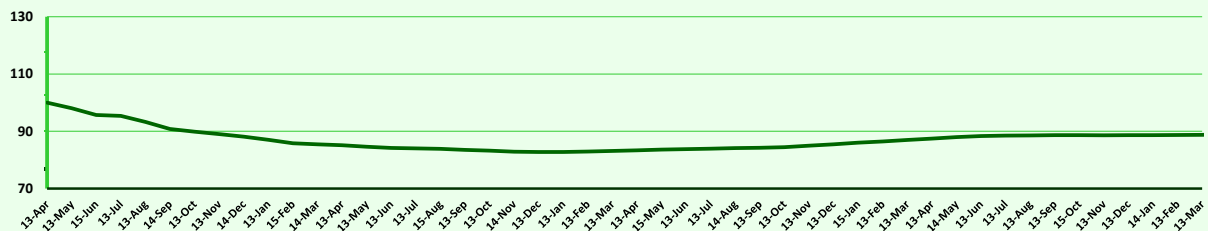
